he Federal Government of Nigeria has applied for financing from the World Bank for a Credit towards the cost of the Nigeria Electrification Project (NEP) and Rural Electrification Agency, the implementation Agency intends to apply part of the proceeds of this credit to payment under the implementation Agency intends to apply part of the proceeds of this credit to payment under the contract for the Consultancy Services for an Independent Verification Agent (IVA) for Result Based Finance Facilities for Solar Home Systems and for the performance based grant program for Mini Grids.

nsulting services ("the Services") include:

a. Conduct an independent verification of claims where actual products supplied under the Solar Home Systems OBF facility are confirmed to exist and be in use by the specified end users. The verifications will serve as a trigger for payments from the PMU to the grantees with the facilitation of the Grants Administrator firm contracted under the project.

b. Establish validity and correctness of sales claims submitted by the grant beneficiaries for products eligible

under the program.

c. Verification of customer connections and satisfactory electricity service as required for the mini grid programs (minimum subsidy tender, and performance-based grants).

The duration of the assignment is 24 months. The assignment is expected to commence in July 2019.

(i) The IVA will be a top tier consulting or audit firm with a minimum of five (5) years operational existence as an organization.

- Capacity to verify transactions:

 Demonstrated experience in verification exercises, socio-economic studies and field/on-site studies;

 Proof of accounting, audit and finance background will be essential;
 - Experience in organizational and project assessments including
- systems review;

 Past roles in project transaction verification will be an advantage.
- Ability to deploy resource persons in multiple rural locations if and as necessary.

 Experience with the rural economy through past assignments. Familiarity with rural energy interventions will be advantageous including engagement with energy
- product or service providers.

 Ability to deploy a robust data collection and management system with capacity to track GIS coordinates for the field visits evidence of similar deployment in the past will be essential.

NCC: Nigeria to Hit 70% Broadband Penetration By 2024

Internet users hit 100m

The Executive Vice Chairman of the Nigerian Communications Commission (NCC), Prof. Umar Danbatta, has disclosed that the next national Broadband plan will see the country achieving 70 per cent broadband penetration by 2024.

He made this disclosure

yesterday at the commission's Headquarters in Abuja. Danbatta, while addressing the management team of Danbatta, while addressing the management team of Airtel Africa said that, "We are steadily seeing increase in broadband penetration. As at February, there is a new target of 70 per cent in the next five years. We will come up with new. So, far, no official announcement has been made on that by the minister.

"I am sure government

announcement on the new
national Broadband plan, Phase
2. In the area of data usage,
there is also steady increase

in data usage. We are again seeing that from 4G network

services.

"It is important to talk about other statistics. As at February 2019, we had 174 million Nigerians who had access to telecom voice services. And the number is steadily

And the number is steadily rising. Internet penetration too in real terms is 100 milion."

He commended Airtel Nigeria for being a major player in the expansion of broadband penetration, saying "it is good to see Airtel providing services, especially 4G services. It is also good to hear the level of expansion because we are seeing remarkable improvement in broadband penetration.

"The figures are increasingly are going up. We are at about 33 per cent now. This we can attribute to very ambitious expansion of network operators."

can attribute to very ambitious expansion of network operators like Airtel in places like Lagos, Kano, Rivers, Ibadan, Abuja. This lends credence to figures we are seeing from broadband penetration.

"We are seeing increase in broadband subscription,

especially to services provided

especially to services provided by Airtel. It is good for Nigerians to hear this that Airtel is helping us to hit the broadband penetration target.".

Speaking further he said, "we were supposed to achieve 30 per cent as at December 2018 but we have exceeded that target courtesy of national Broadband Plan.

He added that henceforth, whatever percentage increase NCC will given out in percentage terms will be in reference to the existing Nigerian population, saying all growth parameters are steadily growing courtesy of expansion programme on 4G operators in the country, especially Airtel.

CEO Airtel Nigeria, Mr. Segun Ogunsanya in his reaction said, his organisation was pleased to be at NCC.

Sustain MSME Funding to Reduce Poverty, Emir Tells World Bank

The Emir of Birnin Gwari in Kaduna State, Bawan Allah Zubair Jibril Mai Gwari II, has appealed to the World Bank to sustain the training and funding of Micro, Small and Medium

The project, which focuses on manufacturing and service sectors, Information Communication Technology, entertainment, tourism and hospitality, light manufacturing (and agro-processing industries) and construction became effective in July 2013 and is billed to end March 29.

trained in 2019 were told the grant/funding component of the project has been discontinued and no reason was given for the decision.

Speaking to journalists in Abuja, the royal father, while commending the initiative, however, said the impact would be better felt with funding to enable business owners train and also empower others.

According to him, "If some people have been trained and empowered, I am appealing

to the government that since to the government that since the project is coming to an end at the end of this month, the way government was able to do it when the programme was supposed to end sometime last year but it was extended.

"I am appealing to the federal government through the Minister of Finance, and Minister of Industry, Trade and Investment and any other good person in government to

and investment and any other good person in government to please extend the life of this programme so that these young people who have been trained will be able to reach their goal. After the training, they should also be empowered with the promised finance so that they can go abead."
